Vaxfab Enterprises Limited reports June 2023 Quarter ended net-profit of Rs. 18.59 Lakhs

Ahmedabad; August 5th, 2023- Vaxfab Enterprises Limited (formerly known as Ellora Trading Limited) - BSE Listed Textile trading Company in India, reported Net profit at Rs. 18.59 Lakhs for the Quarter ended June, 2023 which is 97x compared to year ago Net Profit of Rs. 0.19 Lakhs.
